EXPENDITURES

Personnel costs are normally the largest cost for any business and the police department is no exception in this arena. Due to the nature of law enforcement, not being able to predict call activity to any certainty, criminal activity causing overtime for investigative reasons, and for safety reasons (having to replace officers when they are unable to fill a scheduled shift due to sickness, injury, or other reason) the department's overtime costs are always a concern. Management attempts to minimize these costs as much as possible. Listed below is the monthly overtime costs year to date.

In addition to the above table, we are providing a greater detail of the type of overtime the department incurs on a monthly basis. The first table (OT by type) indicates what type of overtime the department incurred. The types of overtime are defined as:

OT-Court: Overtime associated with an officer attending municipal or criminal court or an officer acting as a Court Officer for municipal court.

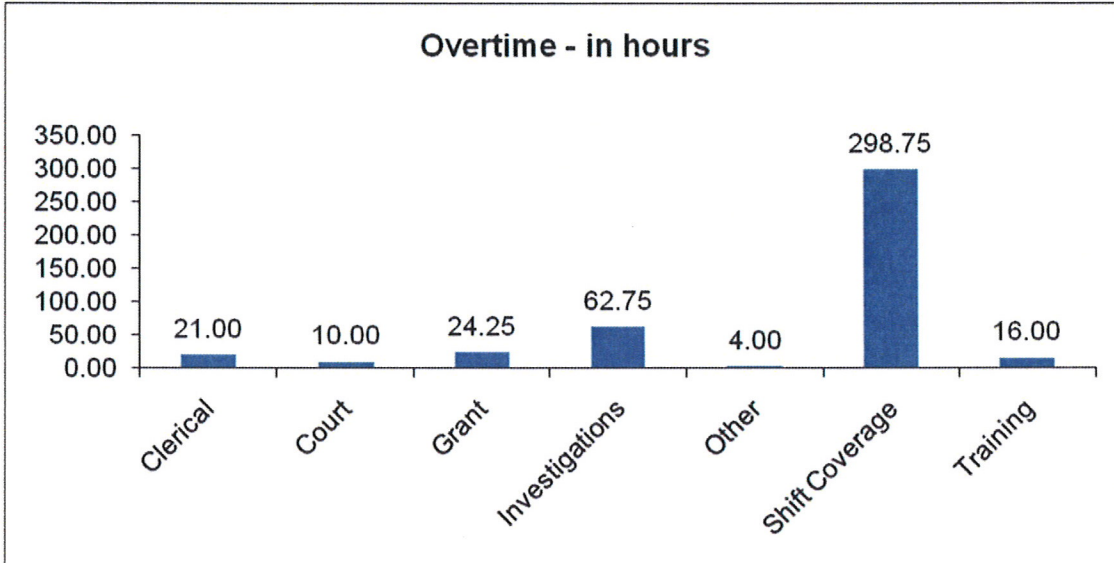
OT-Grant: The department is normally reimbursed from another agency for overtime-related costs in these categories.

OT-Investigations: Includes all overtime related to investigations (shift extension, early call-in, investigations)

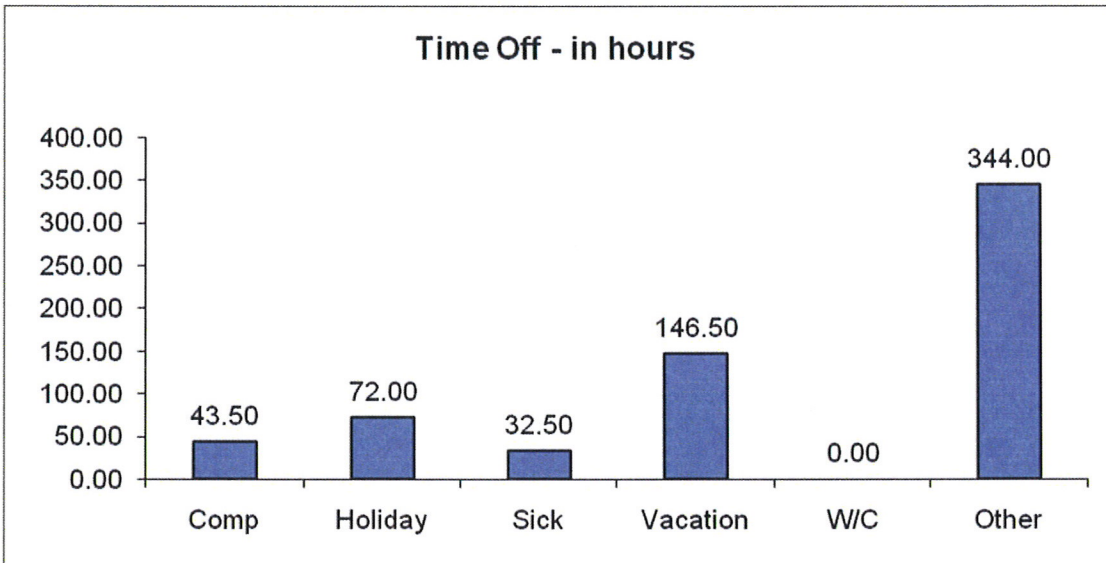
OT-Other: Uncategorized overtime

OT-Shift Coverage: All overtime related to filling in for an officer who is on vacation, sick, holiday, or otherwise unavailable to work the regularly scheduled shift.

OT-Training: Includes all overtime related to that individual officer to attend training



This table explains why an officer may not have appeared to work for their regularly scheduled shift. Time Off Other includes bereavement, **military**, admin. leave, suspension, or other unpaid time off.



### Noteworthy Cases:

On August 2, 2008 Officer Fischer was dispatched to St. Mary's Hospital to investigate a report that person was being treated for injuries received in a domestic battery. Officer Fischer met with the victim and found that her left eye was swollen 2-3 times larger than her right eye. The victim stated that her on again-off again boyfriend of over six years, David Armster, was walking in front of the Capitol Motel announcing that she would perform sexual acts on them for crack. The victim said they argued and she attempted to leave their room. Armster blocked the doorway and physically threw her onto the bed; he held her there and punched her in the eye with his fist. When her eye began to swell Armster let her up. She went to the hospital where the police were called. Armster was charged with battery and disorderly conduct. On October 1, 2008 Armster was found guilty of battery and a disorderly conduct charge was dismissed on prosecutor's motion; he received 30 days with Huber and a fine. (Case # 08-220230)

On August 3, 2008 Officers Wege, Boldebuck and Sgt. Gehn were dispatched to the Pheasant Ridge Trail area to investigate a report of an armed robbery. On arrival Officer Wege met with the male victim and obtained descriptions of several subjects, one of who had held a pistol to his head. Officer Boldebuck located 4 subjects on Deer Valley Road who matched the physical descriptions provided by the victim. Officer Boldebuck followed them to the Hazelwood Court area waiting for back-up to arrive. Sgt Gehn responded and the suspect ran through an apartment building and through a courtyard towards Pheasant Ridge Trail. Officer Boldebuck pursued on foot and Sgt. Gehn drove to Pheasant Ridge Trail; just as the subjects were running across the roadway Sgt. Gehn drove in front of them and they stopped. Three of the subjects were taken into custody. A show-up was completed and the victim identified one of the subjects as being the person who held the pistol and another who had assisted in the robbery of his wallet. Officer Wege interviewed the third suspect who provided information identifying another person involved. Arrested were Tommie Walker and two juveniles, all who were charged with armed robbery and party to a crime of armed robbery. This case is still pending in the court system. (Case # 08-221857)

On August 4, 2008 Sgt. Gehn was dispatched to the Pheasant Ridge Trail area to a report that an ex-boyfriend has been calling the female victim on the phone and is threatening her. The victim informed Sgt. Gehn that her ex-boyfriend, Phillip Buckner, had just called her and said that he was coming to her house with a gun. While Sgt. Gehn was there the telephone rang and Buckner said he was coming over and was going to give her new boyfriend "sixteen with his 9MM auto". Sgt. Gehn took the phone and identified himself to the caller who immediately hung up. The victim left the area and stayed at her boyfriend's apartment. Approximately 30 minutes after the police left the victim's mother, who was babysitting at the victim's apartment, observed Buckner inside the apartment. He left when he was told the victim was not at home. While in the hallway a neighbor told him that he did not need to see the victim. Buckner punched the neighbor with a closed fist 8-9 times. Phillip Buckner was later arrested and charged with 2 counts of telephone harassment, criminal trespass to a dwelling, and battery. On October 2, 2008 Buckner was found guilty of disorderly conduct and battery; the criminal trespass to dwelling and unlawful phone use-threats was dismissed on prosecutor's motion (he received 3 months Huber and a fine). (Case # 08-222936)

On August 9, 2008 Officer Boldebuck responded to the Deer Valley Road area to check on a report of a fight in progress. On arrival Boldebuck observed an intoxicated subject standing with his arms folded near another subject who was lying on the ground in an unconscious state. Officer Boldebuck located a witness who identified the subject standing, as the one who had beaten up the subject on the ground. The suspect was then contacted and identified as Jeffery Jefferson. Jefferson admitted that he had gotten into a fight. Officer Pucillo interviewed the victim at the hospital and found him to be a juvenile. The victim said the suspect swung at him and missed. They then went to the ground where the suspect put his forearm over the victim's throat and applied pressure for nearly a minute. After the assault, he could not get up and others carried him to where the police found him. Jeffery Jefferson was arrested and charged with felony intentionally causing bodily harm to a child. This case is still pending in the court system. (Case # 08-228610)

On August 11, 2008 Officer Weaver responded to the battered woman's shelter to investigate a report of a domestic battery. The victim informed Officer Weaver that she and her boyfriend Patrick Plummer, with whom she has lived for the past six months, had gotten into an argument. Plummer began talking smack and she felt it best to leave for her safety. She packed some clothing Plummer shoved her against the bedroom wall. Plummer held her against the wall and repeatedly hit her in the face. The victim was knocked to the floor and the suspect got on top of her. When she tried to push him off with her arm, he began to bite the bicep area of her upper right arm. The victim stated that he bit her like a dog, grinding his teeth into her, causing her arm to bleed. Officers found bruises and abrasions all over the victim and a 3"x4" bruise where she was bitten. Partick Plummer was arrested and charged with battery, disorderly conduct and bail jumping. Plummer was convicted of battery in Dane County Court. (Case # 08-229907)

On August 13, 2008 Officer Stephens was dispatched to a Dane Street address to investigate a report of a theft and battery. Officer Stephens made contact with the victim who reported that she had observed her daughter steal money from the wallet of an elderly neighbor. The victim confronted her daughter about the theft, at which time the daughter told her to shut her mouth and mind her own business. The suspect came at her mother and grabbed her by the neck and began choking her. Officer Mansavage contacted the neighbor who found he was missing \$39.00 from his wallet. Faith Walker was charged with theft and disorderly conduct. Walker was convicted of disorderly conduct on October 29 and sentenced to 15 days jail with Huber. (Case # 08-231997)

On August 17, 2008 numerous Town of Madison Officers investigated a fight and two shootings, which occurred on Country Rose Court. Evidence technicians recovered over 30 fired shell casings at the scene. Det. Fischer began following up on leads and interviewed a victim who provided information that after the shooting on Country Rose Court, she and her uncle had a pistol pointed at them and were threatened with being shot at her uncle's residence on Seminole Highway, in the city of Madison. Det. Fischer provided vehicle and suspect descriptions of the suspects involved to officers still at the shooting scene investigating. Sgt. Gehn observed a vehicle matching that description pulling into a parking stall on Country Rose Court and he, Officer Pucillo and Officer Wege ran to that location and took three suspects into custody. The owner of the vehicle was located and permission obtained to search the vehicle, where Sgt. Gehn located a fully loaded pistol hidden in the trunk. Tony Longino and Tyrone Wheeler were arrested and charged with negligent handling of a weapon and disorderly conduct by use of a

dangerous weapon, Wheeler was additionally charged with possession of a firearm by a felon. This case is still pending in the Dane County Court system. (Case # 08-237547)

On August 17, 2008 Officer Pucillo and Sgt. Gehn were dispatched to a residence on Ridgewood Way to investigate a report of a man with a gun, who was threatening to shoot the female caller. On arrival the suspect identified as Richard Redman was immediately taken into custody. A search was conducted of the area and the pistol could not be located. The victim gave a statement that Redman and she were in an argument at which time he pulled a pistol from his waistband and pointed it directly at her and stated "I'll take you with me". Richard Redman was arrested on an outstanding warrant and also charged with disorderly conduct by use of a dangerous weapon. On September 3, 2008 Redman was ordered to 60 days jail with Huber to run consecutive with another case. (Case # 08-237465)

### **Personnel Information**

Our two officers hired in July finished their 40 hour orientation training this month. This training included firearms, emergency vehicle operation, and defense and arrest tactics among other areas. We anticipate both officers to be on solo patrol by the end of the year.

We continued our part-time detective hiring process and expect them to start in October or November.

Our July 2008 hiring process continues with the written test slated for August 9.

### **Training**

As with many other departments throughout Dane County, the State of Wisconsin, and the nation, police officer training is a hot topic, especially with the current budget situation in the state and our community. The department has made a commitment to our officers and community to constantly update their training as much as possible. Knowing that training is a budget item it is the department's desire to let the town board and community know how this money is being spent and what training is being offered to our officers.
