EXPENDITURES

Personnel costs are normally the largest cost for any business; the police department is no exception in this arena. Due to the nature of law enforcement, not being able to predict call activity to any certainty, criminal activity causing overtime for investigative reasons, and for safety reasons (having to replace officers when they are unable to fill a scheduled shift due to sickness, injury, or other reason) the department's overtime costs are always a concern. Management attempts to minimize these costs as much as possible. Listed below is the monthly overtime costs year to date.

In addition to the above table, we are providing a greater detail of the type of overtime the department incurs on a monthly basis. The first table (OT by type) indicates what type of overtime the department incurred. The types of overtime are defined as:

OT-Court: Overtime associated with an officer attending municipal or criminal court or an officer acting as a Court Officer for municipal court.

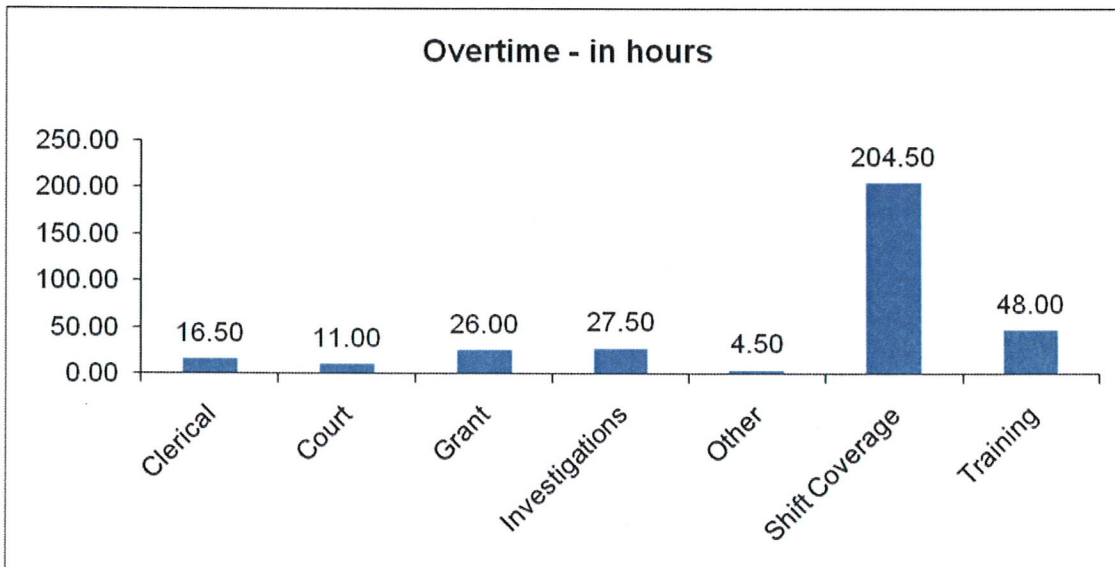
OT-Grant: The department is normally reimbursed from another agency for overtime-related costs in these categories.

OT-Investigations: Includes all overtime related to investigations (shift extension, early call-in, investigations)

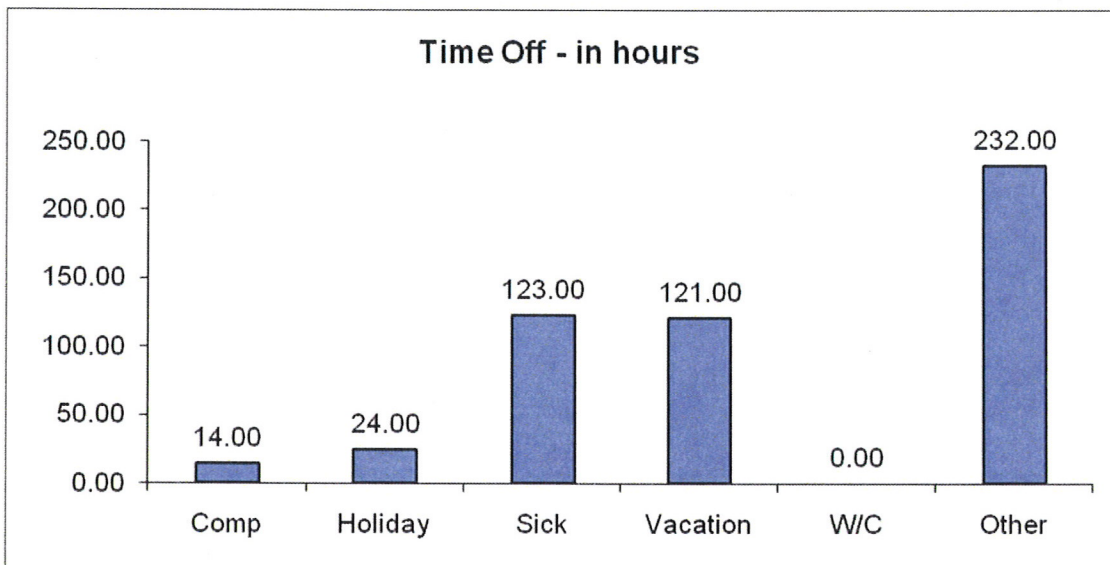
OT-Other: Uncategorized overtime

OT-Shift Coverage: All overtime related to filling in for an officer who is on vacation, sick, holiday, or otherwise unavailable to work the regularly scheduled shift.

OT-Training: Includes all overtime related to that individual officer to attend training



This table explains why an officer may not have appeared to work for their regularly scheduled shift. Time Off other includes; bereavement, military, admin. leave, suspension, or other unpaid time off.



Noteworthy Cases:

On June 9, 2008 Officer Withee was dispatched to an address on Fordem Court to investigate a report of a domestic battery. Officer Withee learned the female victim had been thrown to the ground three times and was struck in the back of the head numerous times. On June 3, 2008 the suspect Justin J. Stieren had thrown a large rock and struck the victim in the triceps causing a large bruise. On June 5, 2008 the victim was punched in the head by Stieren and knocked to the ground he also grabbed a serrated kitchen knife and told the victim that he was going to kill her. Justin Stieren was arrested and charged with three counts of battery, disorderly conduct and use of a dangerous weapon.

On June 4, 2008 Officer Mansavage responded to a Pheasant Ridge Trail address to check on a reported battery. The victim was pushed onto a couch by her boyfriend Travis T. Lee; he grabbed her by the throat, choked her and hit her in the face. Lee then placed her in a headlock and continued to choke her. Lee was arrested and charged with battery, strangulation and two counts of bail jumping.

On June 9, 2008 Officers Wege and Boldebuck were dispatched to a Deer Valley Road address regarding a report of a subject yelling, swearing and trying to force his way into an apartment where his ex-girlfriend lives. The suspect, Ryan K. Crawford, went across the street to use a telephone. Crawford gave the owner of the telephone a jar containing numerous items of jewelry. Officer Wege obtained the property, the ex-girlfriend identified the jewelry as hers and stated Crawford took the property without her permission. Sergeant Gehn located Crawford behind the apartment building and took him into custody. He was jailed under charges of disorderly conduct and theft.

On June 13, 2008 Officer Withee made contact with a female victim at the Town of Madison Police Department. The victim drove her on-again, off-again boyfriend to an address on Frazier Place. When they arrived he refused to get out of the car and grabbed the victim's purse and tried to take it. The victim struggled with him and was able to get the purse back. The suspect, Andre R. Mazarra, then exited the vehicle and kicked the door causing a large dent. He also kicked the side mirror of the vehicle and knocked it off. Mazarra was charged with disorderly conduct and criminal damage to property.

On June 14, 2008 Officer Mansavage met with the victim of a domestic incident at an Ashford Lane address. The victim reported she and her live-in boyfriend, with whom she has an 11-month old child, had gone out that evening; her boyfriend became intoxicated. The boyfriend, Ryan E. Thomas, was in two arguments with other people that nearly resulted in fights. This behavior caused the victim to leave the bar early with a friend. After she left she received a text message from Crawford saying that he had "trashed the bathroom". When the victim returned to their residence they argued and Crawford threw an ashtray across the living room. He did cause damage in the bathroom as he indicated to the victim in the text message. Thomas also broke a coffee mug in the kitchen and burned a photo of the victim. Thomas was arrested and charged with domestic disorderly conduct.

On June 29, 2008 Officer Mansavage responded to a Fordem Court address to investigate a report of a stabbing. On arrival Officer Mansavage contacted the victim who had a large bandage on his head and had an extremely large amount of blood on his shirt.

There was also blood in the apartment and on door handles. The suspect, Maria H. Garcia, had been drinking and suspected the victim of having an affair. The victim was standing with his back to Garcia and suddenly felt himself being stabbed in the shoulder from behind. The victim turned to face the suspect and she swung the knife in an overhand direction at the victim. She did this three or four times and on one of the swings she struck the victim on the head causing a large cut to his scalp. Garcia was arrested and charged with felony reckless endangerment.

Personnel Information

The department continued our January 2008 hiring process. This month background investigations were completed on the top three applicants. Two of the applicants were given conditional offers of employment with medical and psychological screening occurring. Both candidates passed the screenings and were provided with dates of hire in July.

We also posted an advertisement for our July 2008 hiring process. This hiring process will hopefully provide the department with a eligibility list of candidates should a vacancy occur. We expect this process to be completed in January 2009 with the eligibility list good through July 2009.

Training

As with many other departments throughout Dane County, the State of Wisconsin, and the nation, police officer training is a hot topic, especially with the current budget situation in the state and our community. The department has made a commitment to our officers and community to constantly update their training as much as possible. Knowing that training is a budget item it is the department's desire to let the town board and community know how this money is being spent and what training is being offered to our officers.²
