## EXPENDITURES

Personnel costs are normally the largest cost for any business; the police department is no exception in this arena. Due to the nature of law enforcement, not being able to predict call activity to any certainty, criminal activity causing overtime for investigative reasons, and for safety reasons (having to replace officers when they are unable to fill a scheduled shift due to sickness, injury, or other reason) the department's overtime costs are always a concern. Management attempts to minimize these costs as much as possible. Listed below is the monthly overtime costs year to date.

In addition to the above table, we are providing a greater detail of the type of overtime the department incurs on a monthly basis. The first table (OT by type) indicates what type of overtime the department incurred. The types of overtime are defined as:

OT-Court: Overtime associated with an officer attending municipal or criminal court or an officer acting as a Court Officer for municipal court.

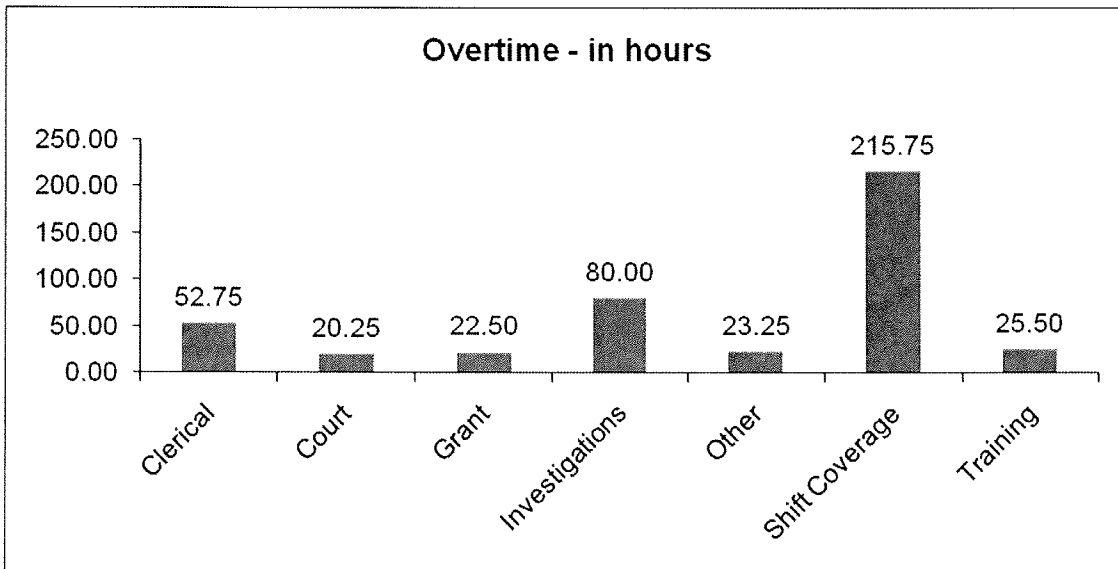
OT-Grant: The department is normally reimbursed from another agency for overtime-related costs in these categories.

OT-Investigations: Includes all overtime related to investigations (shift extension, early call-in, investigations)

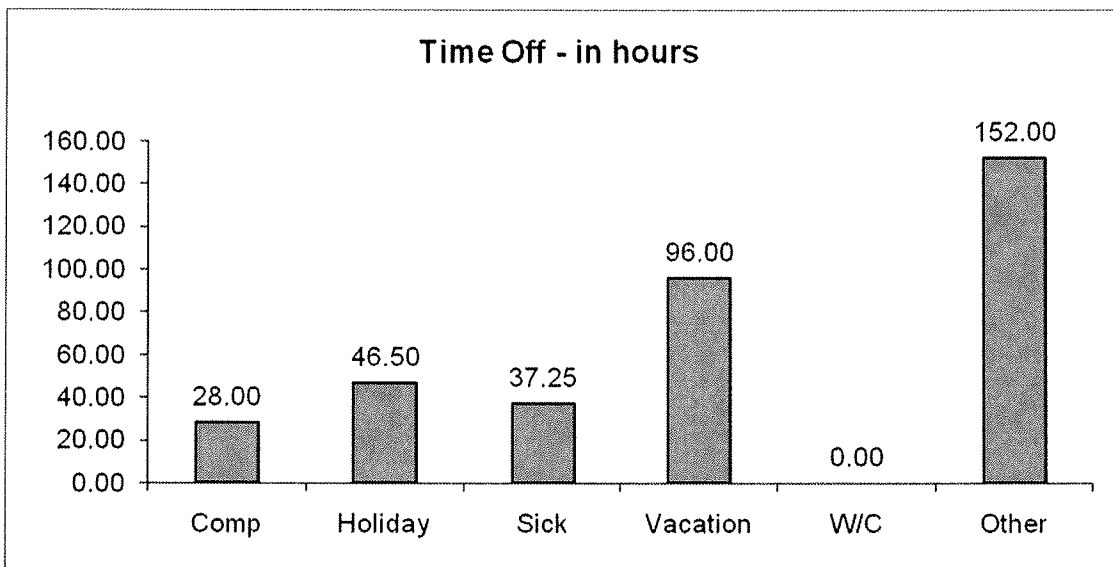
OT-Other: Uncategorized overtime

OT-Shift Coverage: All overtime related to filling in for an officer who is on vacation, sick, holiday, or otherwise unavailable to work the regularly scheduled shift.

OT-Training: Includes all overtime related to that individual officer to attend training



This table explains why an officer may not have appeared to work for their regularly scheduled shift. Time Off other includes; bereavement, military, admin. leave, suspension, or other unpaid time off.



### **Noteworthy Cases:**

On May 2, 2008 Officer Parks made contact with a female juvenile who informed him that while on Deer Valley Road she heard several females yell at her. These subjects then began to run at her and she recognized one of them. The victim was taken to the ground where she was kicked and punched numerous times. The suspect then began choking her while others continued to kick and punch her. The suspect also bit her in the lower leg.

Officer Parks conducted a photo lineup containing a photo of the suspect; the victim identified the suspect. The suspect was charged with physical abuse of a child and intentionally causing bodily harm. (08-117657)

On May 3, 2008 Officer Wege was dispatched to Pheasant Ridge Trail where two mothers were complaining a neighbor had caused their children to expose themselves to him. The suspect, identified as Robert Nelson, brought some balls outside for their children to play on. One of the children told the suspect she needed to urinate. Nelson told her she could urinate on the ball. Nelson took the ball inside and came back out and told the same girl and another girl that they could take their pants off and they did. Nelson was interviewed by Officer Wege and Sgt. Gehn; Nelson admitted that he had found "seeing little cheeks" gratifying. Nelson was arrested and charged with two counts of causing a child to expose their pubic area. (08-117962)

On May 5, 2008 Officer Fischer was on patrol in the Pheasant Ridge Trail area. Officer Fischer observed a male subject acting suspiciously going in and out of known drug buildings. Officer Fischer approached the subject and requested him to stop so she could talk to him. The suspect ran away from her and Officer Fischer began a foot pursuit. Officer Fischer caught the suspect after chasing him for about one block. While the suspect was running he threw the drugs; Officer Fischer was not able to locate the discarded drugs. Dwight Ferge was arrested for obstructing an officer.

On May 12, 2008 Det. Krause and Officer Stephens were dispatched to the Pheasant Ridge Trail area to investigate a report of a woman screaming. The officers located a female victim who stated she was drinking with some friends in an apartment and she went into the bedroom to lie down. A man identified as William K. Sims laid down next to her for 15-20 minutes; the victim decided to get up and leave the bed. Sims grabbed her by the throat and squeezed forcefully. The victim managed to push him away, scream for help and ran into the bathroom.

The victim then ran to the kitchen to get a phone and Sims followed her there and again grabbed her by the throat with both hands to the point where she could not breathe. The victim passed out and woke up on the kitchen floor. The victim told officers this same type of incident occurred two weeks ago. William Sims was arrested and charged with two counts of strangulation and suffocation and substantial battery. (08-127535)

On May 17, 2008 Officer Boldebuck investigated a reported sexual assault. Officer Boldebuck learned from the female victim she had gone to a residence to buy crack cocaine, however when she got there the dealer locked the door behind her and ordered her to pull her pants down. He threatened the victim by telling her he had a gun; she

complied with the suspect's demand and pulled her pants down. The suspect who was later identified as Charles Homesley then forcefully assaulted the victim. The victim had severe injuries. Homesley was arrested and charged with five counts of second-degree sexual assault, and false imprisonment. (08-132751)

On May 24, 2008 Officer Stephens was dispatched to Pheasant Ridge Trail. A caller reported that a vehicle was smashing into a dumpster and a woman was yelling, "She's going to kill me!" Officers learned the victim was in a vehicle with Maria Garcia when Garcia began striking the victim in the face and at one point pulled her hair very hard. Garcia then drove the victim's car into a dumpster at least twice. When contacted and arrested Garcia's purse was searched and a baggie of marijuana weighing 3.85 grams was located. Garcia was charged with battery, disorderly conduct, obstructing an officer, possession of marijuana and possession of drug paraphernalia. (08-139745)

On May 26, 2008 Officer Fischer contacted a female victim who stated that her ex-boyfriend and the father of her 8-month-old child called and wanted to meet so he could see the child. The father, Gustavo Gutierrez-Malpiz, persuaded the victim into his car. The suspect told the victim she could not get out and he was taking her to Chicago. The victim tried to call for help and the suspect took the cellular phone away. The victim tried to jump out of the vehicle and the suspect grabbed her arm to prevent her from leaving. She was then struck on the head three times and bitten on the leg and hand by the suspect. Gustavo Gutierrez-Malpiz was charged with false imprisonment, three counts of battery and felony intimidation of a victim. (08-142314)

### **Personnel Information**

The department continued our January 2008 hiring process. The police chief conducted six interviews for our vacant police officer positions. The police chief requested background investigations on three of the six candidates. Those background investigations were pending at the end of May.

### **Training**

As with many other departments throughout Dane County, the State of Wisconsin, and the nation, police officer training is a hot topic, especially with the current budget situation in the state and our community. The department has made a commitment to our officers and community to constantly update their training as much as possible. Knowing that training is a budget item it is the department's desire to let the town board and community know how this money is being spent and what training is being offered to our officers.<sup>2</sup>
