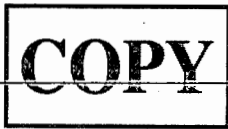

COMPLAINING WITNESS

Gehn/Boldebuck/Retlick/Parks/Garton

The above-named complaining witness being first duly sworn states the following:

Count 1: 1ST DEGREE SEXUAL ASSAULT OF A CHILD UNDER AGE 13 WITHOUT GREAT BODILY HARM

The above-named defendant on or about Friday, February 23, 2007, in the Town of Madison, Dane County, Wisconsin, did have sexual intercourse with a child under the age of thirteen, NCC, DOB 03/08/2001, which did not result in great bodily harm to said child, contrary to sec. 948.02(1)(b), 939.50(3)(b) Wis. Stats., a Class B Felony, and upon conviction may be sentenced a term of imprisonment not to exceed sixty (60) years.

Count 2: 1ST DEGREE SEXUAL ASSAULT OF A CHILD UNDER AGE 13 WITHOUT GREAT BODILY HARM

The above-named defendant on or about Friday, February 23, 2007, in the Town of Madison, Dane County, Wisconsin, did have sexual contact with a child under the age of thirteen, NCC, DOB 03/08/2001, which did not result in great bodily harm to said child, contrary to sec. 948.02(1)(b), 939.50(3)(b) Wis. Stats., a Class B Felony, and upon conviction may be sentenced a term of imprisonment not to exceed sixty (60) years.

Count 3: INCEST

The above-named defendant on or about Friday, February 23, 2007, in the Town of Madison, Dane County, Wisconsin, did have sexual contact with a child he knows is related by blood or adoption, to a degree of kinship closer than second cousin, NCC, DOB 03/08/2001, contrary to sec. 948.06(1), 939.50(3)(c) Wis. Stats., a Class C Felony, and

upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

FACTS: Town of Madison Police Department officer Jessica Fischer reports that on 02/23/2007, she was dispatched to Meriter Hospital, where a child, herein identified as NCC, 03/08/2001, was being examined by a Sex Assault Nurse Examiner (SANE) nurse. Officer Fischer reports that the child's mother, Maria Cordero-Cirio, reported that earlier this date, she saw blood in the child's underpants. When she asked the child about this, the child stated that the defendant herein, the child's cousin by blood, had touched her private parts, that he had "put his part inside my part," and that this had hurt her. NCC stated that he had done so in the past also.

TMPD Detective Rob Hale reports that the SANE nurse who examined NCC, Sarah Sturdevant, reported the following: the child's anus was swollen, with some evidence of external bruising. There were multiple tears around the circumference of the anus. The interior of the anus showed trauma also. There were fresh tears and abrasions to the perineum. These were bleeding, some of the outer layer of skin had been abraded away, and pieces of skin were hanging. The vagina was red. There was an old, healed scar in the posterior fourchette.

Detective Hale reports that on 02/24/2007 he spoke with the defendant herein, who identified himself verbally. Detective Hale told the defendant he was investigating the sexual assault of NCC. The defendant stated that on 02/23/07, he was at NCC's residence on Badger Lane, which your complainant knows is in the Town of Madison, Dane County, Wisconsin. He stated that he believes NCC is his cousin. He initially denied having touched her. He also stated, "I need help. I did this." He stated that while at NCC's residence on 02/23/07, he put his finger inside NCC's anus. He stated that both he and she were fully clothed when he did this, and that he reached inside her clothing. He unzipped and unbuttoned her pants, exposed his penis and put his penis against her vagina. He said he rubbed his penis against her vagina forcefully. He insisted that he did not penetrate her vagina. He said he couldn't see if she was crying. He insisted that he had not done this before. He stated he needed help, "because it is not good what I am doing."

Your complainant is an officer for the TMPD, who believes Officer Fischer's and Detective Hale's reports reliable because written in the course of official duties; the statements of citizen witnesses are reliable because based on personal knowledge; the statements of the defendant are reliable because they are against his penal interest.
